About the Gallery

The Gallery at Pavilion I is a Class-A office building located within the ViBe Creative District, the newest art and cultural hub in Hampton Roads. At just six blocks from the Oceanfront, it is easily within walking distance of the Museum of Contemporary Art (MOCA), the Virginia Beach Convention Center, and many retail shops, restaurants, and health and wellness facilities. There are five (5) floors of space available for displaying art, each with a 23ft wall opposite the elevators so the work is seen immediately upon exit of each floor and in the lobby. Art work is available for public viewing from 9am-5:30pm M-F; and Opening Receptions typically attract 50-100 people.

What we do

- Install the artwork
- Host your Opening Reception by providing setup, cleanup, wine, and light hors d'oeuvres
- Promote your exhibition on Facebook and request inclusion in the event section of the Virginian Pilot
- Provide insurance against theft or damage while art work is in the building

Your checklist

- Handle transportation of art to and from the building
- Provide any pedestals or display boxes necessary to show sculpture or similar pieces
- Provide title tags for each piece displayed
- Send out invitations and provide an approximate guest count at least 5 business days prior to the Opening Reception
- Arrange desired layout of art on a previously agreed upon hang date
- Provide itemized list of the value of all artwork displayed to include title and location
- Handle all sales
 - All proceeds from sales will go to the artist
 - The Runnymede Corporation will direct all sales inquiries to the artist
 - The Runnymede Corporation will not accept any payment from buyers nor be involved in the pick up or delivery of sold art to the buyers.
 - Items sold must be replaced to avoid empty walls (or buyers must wait until the end of the exhibition to take possession of items). Item value lists should be updated for insurance purposes.
